Christie Signs Next-Of-Kin Law

On February 6, 2017, Gov. Chris Christie signed the Next-of-Kin law, which requires administrators of senior housing facilities to establish and implement procedures for collection of emergency contact information of a person to be notified in the event of the death of a senior citizen residing in the facility. The requirement applies to any rooming house, boarding house, residential health care facility, assisted living facility, nursing home, continuing care retirement community, and public housing designated for seniors.

Effective immediately, the law requires an administrator to notify the emergency contact, in the event of the death of the senior citizen within 24 hours. If the administrator fails to comply with the law, they face a \$500 civil penalty. The Commissioner of Community Affairs is to adopt regulations that govern the notification procedures.

VAWA Update - What You Need to Know

LeadingAge New Jersey recently hosted an audio presentation on the implications of VAWA provisions for multi-family housing. All housing providers are urged to become familiar with these provisions and act immediately to ensure all properties are operating within the new standards.

HUD's final rule under the Violence Against Women Act (VAWA) Reauthorization of 2013 was published in the Federal Register on November 16, 2016, provisions effective December 16, 2016. Some of the provisions include:

- **Codifies core protections** - Ensures that survivors are not denied assistance, evicted, or terminated from housing assistance for being a victim, or being affiliated with a victim, of domestic and dating violence, sexual assault, or stalking.
- **Emergency transfers** - Allows survivors to move to another available unit if they fear for their life and safety. The final rule includes a model emergency transfer plan and an emergency transfer request form. PHAs will have 180 days, until June 14, 2017, to develop emergency transfer plans.
- **Protections against denials, terminations, and evictions that directly result from being a victim of domestic violence, dating violence, sexual assault, or stalking** - Survivors often face denial, termination, or eviction for reasons that seem unrelated to being a survivors, such as poor rental history or poor credit, but is actually a direct result of being a survivor of domestic and dating violence, sexual assault, and stalking. The final rule prohibits any denial, termination, or eviction that is a direct result of the fact that the applicant or tenant is or has been a victim of domestic violence, dating violence, sexual assault, or stalking, if the applicant or tenant otherwise qualifies for admission, assistance, participation, or occupancy.
- **Low-barrier certification process** - Enables survivors to exercise their VAWA rights through self-certification in most cases, easing the barrier of third-party validation. The final rule includes a certification form that may be used by covered housing providers.
