

Preparing for a REAC inspection can be very daunting for owners, agents as well as your on-site maintenance personnel. Not knowing why your property received a high number of point deductions on a particular deficiency, or why certain deficiencies are cited by some inspectors and omitted by others, are common concerns. Many individuals just don't understand the physical inspection process.
